Section 1. That Ordinance No. 12700 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 766809, as adopted and amended therein, by appropriating an additional \$238,140 from the General Fund Unappropriated Revenues to the General Fund, Building Inspection Department, to fund 20 additional positions.

Section 2. That the expenditure and transfer of the sum of \$238,140 from the General Fund Unappropriated Revenues to the General Fund, Building Inspection Department, is hereby authorized.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public

hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
