AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY APPROPRIATING FROM SEWER REVENUE FUND UNAPPROPRIATED REVENUE \$1,536,000 TO THE SEWER REVENUE FUND UNALLOCATED RESERVE AND \$1,815,000 TO THE SEWER REVENUE FUND NONPERSONAL EXPENSE TO HELP FINANCE IMPROVEMENTS TO THE SEWAGE TREATMENT FACILITIES AND PROVIDE FOR THE GENERAL INCREASE IN OPERATING COSTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 766809 as amended by Document No. 766810, as adopted and amended therein, by appropriating from Sewer Revenue Fund Unappropriated Revenue \$1,536,000 to the Sewer Revenue Fund Unallocated Reserve and \$1,815,000 to the Sewer Revenue Fund Nonpersonal expense to help finance the improvements to the Sewage Treatment Facilities and provide for the general increase in operating costs.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public

hearings, pursuant to the authority contained in Sections 16,
17 and 71 of the Charter of The City of San Diego.




