Diego, as follows:


Section 1. That Lot 129, Encore Mira Mesa Unit

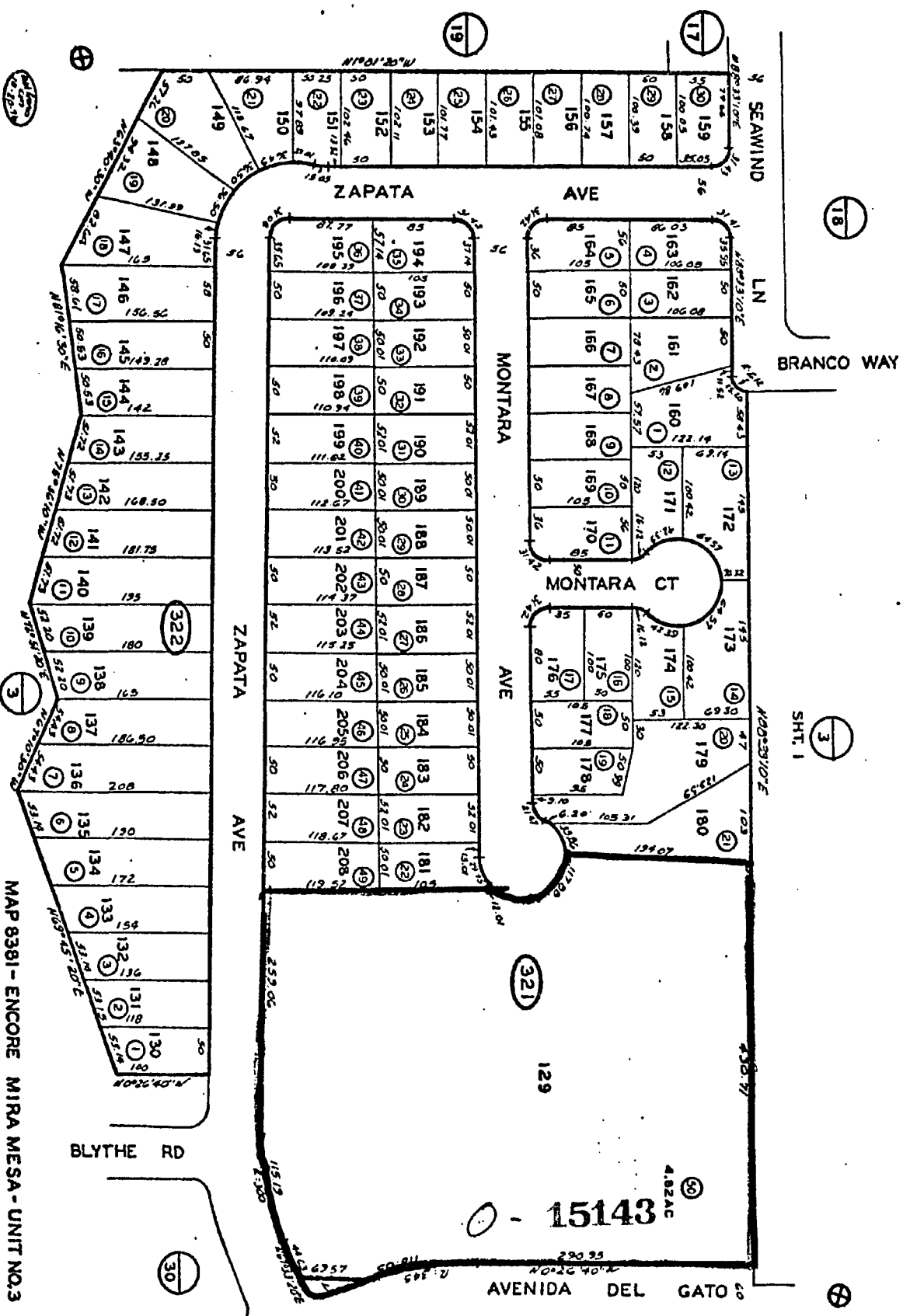
