

RESOLUTION NO. 221721Adopted on AUG 29 1978

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Maryanne Piumatti	City Auditor	\$ 25	Ms. Piumatti is an Intermediate Typist. She suggested the elimination of the posting of supply prices on the City Auditor's Stores Requisitions. This was felt to be no longer needed and saves \$260 annually.
Clifford D. Loomis	Housing and Community Services	\$ 20	Mr. Loomis is a Van Driver. He suggested that the service tow truck be equipped to perform minor repairs on downed City vehicles. This resulted in equipping the truck with jumper cables and other minor equipment.
Myrna F. Choate	Risk Management	\$ 20	Ms. Choate is an Administrative Aide I. She suggested that only one copy of suggestions be sent to evaluators. Since most evaluators were returning the second copy anyway, this saves an estimated \$204 annually.
Barbara J. Butler	Police	\$ 20	Ms. Butler is an Intermediate Typist. She suggested that zip codes be placed on all crime/incident reports. This saves approximately \$200 a year in search time.
James H. Kline	Fire	\$ 10	Mr. Kline is a Fire Captain. He suggested that certain lights in Parker Hall be replaced. This is expected to save energy.
