WHEREAS, with the approval of the final map of MIRA MESA WEST UNIT NO. 2 subdivision, the City shall receive easement interests which allow the quitclaim of existing sewer, slope and drainage easements within the subdivision; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. 765452, quitclaiming to Pardee Construction Company, a California corporation, all the City's right, title and interest in the sewer, slope and storm drain easements, as more particularly described in said quitclaim deed.
