That the acceptance by the City Manager of that Grant Deed of WILLIAM BROWN, executed in favor of The City of San Diego, bearing date of November 9, 1978, conveying to said City all that portion of Lot 3 of Beck Subdivision, Map 3457, as more particularly described in said deed, be and the same is hereby approved; and that the land therein conveyed for street purposes is hereby dedicated as and for a public street and the same is hereby named RITCHEY STREET.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$4,300 from Capital Outlay Funds, CIP 39-004(9), for acquisition of said land and related costs is hereby authorized.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
