WHEREAS, The City of San Diego is the owner of certain easements for open space, pedestrian and non-motor vehicular purposes in Lots 8, 9 and 10, Villa La Jolla Unit No. 4, Map No. 6985; and

WHEREAS, said easements are unneeded for the purposes for which they were granted and the City has acquired certain easements in exchange for said unneeded easements; and

WHEREAS, the City Manager has determined that the value of the easements acquired are approximately equal to the value of the easements to be quitclaimed pursuant to this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the Mayor and City Clerk are hereby authorized and empowered to execute two deeds, copies of which are on file in the office of the City Clerk as Document Nos. 765470 and 765471, quitclaiming to MUTUAL BENEFIT LIFE INSURANCE COMPANY, a corporation, and to LA JOLLA VILLAGE SQUARE, a limited partnership, unneeded easements for open space, pedestrian and non-motor vehicular purposes affecting Lots 8, 9 and 10, Villa La Jolla Unit No. 4, Map No. 6985, as more particularly described in said deeds.
