BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Joint Powers Agreement with the CITY OF DEL MAR for a traffic study in the vicinity of Via De La Valle/Valley Road, Turf Road and Jimmy Durante Boulevard, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 765416.

BE IT FURTHER RESOLVED, that the expenditure of \$2,000 previously reserved for the study under Resolution No. 221861 adopted on September 18, 1978, is hereby authorized from the Allocated General Fund Reserve (53.20) solely and exclusively for the purpose of providing funds for the City's 25% share of the cost of said study.
