
\$89,000 from Capital Outlay Fund 245

\$ 3,600 from Sewer Revenue Fund 506

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the work of improving the radio communications systems for the Police, Fire, General Services and Water Utilities Departments of The City of San Diego, California, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.
