
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That in accordance with Council Policy 400-7 the City Manager be and he is hereby authorized to change the standard form of water and sewer reimbursement agreements to provide that the administrative costs to be paid to the City for the processing of said agreements shall be as follows:

1. The original developer shall pay the City \$300.00 upon his execution of the agreement; plus
 2. One percent (1%) of the cost of any project which is \$100,000 or less; payable to the City as reimbursements to the original developer as subsequent developers make such payments; plus
 3. An additional one-half percent (1/2%) of the cost of any project which is in excess of \$100,000; payable to the City as reimbursements to the original developer as subsequent developers make such payments;
- provided that all of the percentage payments set forth above shall be shared equally by the original developer and any subsequent developers.
