1. That the sole bid of \$29,600.00 by L. A. MC KIBBIN dba MC KIBBIN CO. for the REPAIR OF STORM DRAIN BETWEEN WASHINGTON STREET AND BUSH STREET ( STORM DAMAGE REPAIR) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764964.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$39,400.00 from the Disaster Assistance Fund 39024 to CIP 11-170.
3. That the City Auditor and Comptroller is hereby authorized to add CIP No. 11-170 (REPAIR OF STORM DRAIN BETWEEN WASHINGTON STREET AND BUSH STREET (STORM DAMAGE REPAIR) to the FY 1979 Capital Improvements Program.
4. That the expenditure of \$39,400.00 from the Disaster Assistance Fund 39024 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
