WHEREAS, it is desirable and appropriate that the City Council establish for planning purposes a list of priorities for the retention of open space areas in The City of San Diego and;

WHEREAS, the City staff will utilize such recommended priorities for planning purposes in determining which open space areas will be recommended for acquisition utilizing bond revenues from Proposition "C"; and

WHEREAS, the Park and Recreation Board and the Public Facilities and Recreation Committee have recommended the adoption of recommended priorities for the retention of open space as set forth in that Report to the Honorable Mayor and City Council from the City Manager dated October 17, 1978, a copy of which is on file in the office of the City Clerk as Document No. 765558; NOW, THEREFORE,
