WHEREAS, declaration of a disaster will allow the affected homeowners to take advantage of the provisions of Proposition 8 recently approved by the voters of California; and

WHEREAS, this action will allow the Governor to declare a state of disaster thereby invoking the above-mentioned Proposition 8; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said City hereby declares that a disaster existed on September 25, 1978, severly damaging or destroying the following locations:
