

RESOLUTION No. 222564

Adopted on JAN 9 1979 (R-79/214)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of MACHINERY DISTRIBUTION COMPANY is hereby accepted and the City Manager is hereby authorized to execute a contract as follows:

1. Lease of ONE (1) BULLDOZER (KOMATSU MODEL D155A-1) WITH RIPPER for a period of one (1) year at a cost of \$59.00 per hour with an option to continue lease for two (2) additional one (1) year periods per prices on file in the Purchasing Department; also with an option to lease two (2) additional machines at these same prices, terms and conditions, option to be exercised within sixty (60) days after delivery of initial machines. Terms $\frac{1}{2}$ of 1%, 10 days.
2. Lease of two (2) BULLDOZERS (KOMATSU MODEL D155A-1) with counterweights for a period of one (1) year for a cost of \$57.00 per hour with an option to continue lease for two (2) additional one (1) year periods per prices on file in the Purchasing Department; also with an option to lease four (4) additional bulldozers at these same prices, terms and conditions to be exercised within sixty (60) days after delivery of initial machines. Terms $\frac{1}{2}$ of 1%, 10 days.
