

RESOLUTION No. 222566 (R-79-1183)

Adopted on JAN 9 1979 (REV)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the SAN DIEGO HOUSING COMMISSION is hereby delegated the function of reviewing the inventory of City-owned lands which have been designated for low income housing purposes.

BE IT FURTHER RESOLVED, that said Commission is also delegated the function of reviewing all pending and future proposed transactions or matters relating to the use of low income housing designated City-owned lands and making recommendations with regard to all such matters to the Housing Authority or City Council.

BE IT FURTHER RESOLVED, that the purpose of this delegation is to allow the Commission to review the inventory of City-owned properties designated by the Council for low income housing, to solicit proposals, to negotiate agreements regarding City-owned properties for low income housing purposes and to recommend final action to the Housing Authority or City Council, as may be appropriate with the understanding that it is the intent of the City Council that such City-owned properties shall be leased, rather than sold, for low income housing purposes, except in exceptional circumstances.
