WHEREAS, DEE J. ROGERS joined the San Diego Fire Department on September 19, 1944; and

WHEREAS, he was promoted to Engineer in 1950, Lieutenant in 1956, Captain in 1961, Battalion Chief in 1967, Assistant Chief in 1972, Deputy Chief in 1974, and Fire Chief on January 17, 1975; and

WHEREAS, Chief Rogers is largely responsible for convincing the state's Fire Insurance Rating Bureau that San Diego's fire insurance rates be lowered; and

WHEREAS, Chief Rogers represented the City and other agencies throughout the state to insure that CAL-OSHA standards which are imposed are reasonable and result in a benefit to all taxpayers; and

WHEREAS, the costly fire and telephone alarm box system was phased out under Chief Rogers' direction; and

WHEREAS, Chief Rogers' 34 years of dedicated service and leadership has been an inspiration to the firefighters whom he has directed and those of us who have worked with him; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego and its citizens do hereby express their gratitude and admiration to Dee J. Rogers who has so ably directed the Fire Department as Chief for the last four years.
