WHEREAS, on November 30, 1978, the Planning Commission voted 5 to 1 to deny the appeal, approve the tentative map and uphold the decision of the Subdivision Board; and

WHEREAS, said appeal was set for public hearing on January 9, 1979, continued to January 16, 1979, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; and

WHEREAS, the City Council in considering said appeal is empowered by the provisions of Municipal Code, Section 102.0308, to affirm, reverse or modify, in whole or in part, any determination of the Planning Commission subject to the limitations as are placed upon the Planning Commission by the Municipal Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

All of the following facts exist with respect to Tentative Subdivision Map 78-109:

- The proposed map is consistent with the General Plan and Southeast San Diego Community Plan which designate the property for residential use.
- The design and proposed improvements for the subdivision are consistent with the General Plan and Southeast San Diego Community Plan and R-1-5 and R-2A Zoning/Development Regulations and PRD 125.
- The site is physically suitable for residential development.
- The site is suitable for the proposed residential density of development.
- The design of the subdivision and the proposed improvements will not cause substantial environmental damage, based upon the findings of the Environmental Report EQD 78-03-24 EIR which the Subdivision Board has reviewd.
- The design of the subdivision and the type of improvements will not likely cause serious public health problems inasmuch as the map is consistent with R-1-5 and R-2A zoning and conforms with City development regulations and PRD 125.
  - The design of the subdivision and the type of improvements are such that they will not conflict with any easements, acquired by the public at large, for access through or use of property within the proposed subdivision.
