

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a grant agreement with the STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION for the purpose granting an amount not to exceed the sum of \$13,000 for retaining consultants to conduct a plant survey, said grant agreement is on file in the office of the City Clerk as Document No. 765519.

BE IT FURTHER RESOLVED, that the expenditure of \$13,000 out of Trust Fund 3021 of The City of San Diego, be hereby authorized, solely and exclusively, for the above purpose contingent upon receipt of \$8,000 from William Lyons Co. and Penasquitos Properties.
