

WHEREAS, in connection with the City Council's discussions with regard to establishing a list of priorities for the retention of open space areas in the City of San Diego, members of the public indicated their desire that the owners of property previously assessed through the establishment of special assessment districts for open space acquisition be reimbursed from bond revenues from San Diego Open Space Park Facilities District No. 1 bonds; and

WHEREAS, after discussions, the Council approved the concept of reimbursing property owners within the Navajo, Tecolote and Crest Canyon Assessment District areas from the proceeds of interest earned on the initial issuance of said bonds and that assessments, as yet unpaid, be paid by the San Diego Open Space Park Facilities District No. 1;
NOW, THEREFORE,


BE IT RESOLVED, that the City Council hereby approves in concept the reimbursement to property owners in the Navajo, Tecolote and Crest Canyon Assessment Districts for assessments paid in connection with the acquisition of said canyons and further approves in concept the payment by the San Diego Open Space Park Facilities District No. 1 of the remaining unpaid assessments due on bonds issued for said canyon acquisitions.

BE IT FURTHER RESOLVED, that the payment of said assessments from the interest earned on the initial issuance of open space bonds is hereby approved in concept.
