
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. UNIVERSITY FORD and, 2. PADRE DODGE are hereby accepted and the City Manager is hereby authorized to execute contracts as follows:

1. UNIVERSITY FORD for Section I, TWENTY-THREE (23) FOUR-DOOR SEDANS (FORD FAIRMONT) for a cost of \$4,622.00 each less trade-in allowances as follows: 3 each 1969 Ford Sedans \$300.00 each; one (1) 1970 Ford Sedan \$350.00; one (1) 1971 Ford Sedan \$400.00; one (1) 1974 Ford Sedan \$500.00; one (1) 1973 Ford Sedan \$700.00. Terms, net 30 days.
2. PADRE DODGE for Section III for one (1) FOUR-DOOR STATION WAGON (DODGE ASPEN) for a cost of \$4,996.62, terms net 30 days plus tax less trade-in allowance of \$701.00.
3. Rejecting all bids for Section II - Intermediate Size Sedan.


