APPROVING MAP OF CONCORD SQUARE UNIT NO. 1

JAN 22 1979

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled "CONCORD SQUARE UNIT NO. 1 Being a subdivision of Lot 9, Mira Mesa Crest, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6954 filed in the office of County Recorder of San Diego County, June 3, 1971.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Via Firenza, for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as well as the easement over, under, upon and across Lots 1 and 2 for general utility purposes, all as shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said public street is accepted on behalf of the public


