APPROVING MAP OF THE VILLAS AT FASHION HEIGHTS

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by LEROY C. BODAS, a Registered Civil Engineer, entitled "THE VILLAS AT FASHION HEIGHTS Being a subdivision of Lots 422 to 492, inclusive, of Fashion Heights, Unit No. 3 in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7679, filed in the office of the County recorder of San Diego County on June 28, 1973.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Fashion Hills Boulevard and Camino Lujan, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over, under, upon and across Lots 1 and 2, as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that
