BE IT RESOLVED, by the Council of The City of San Diego, that the plans, drawings, typical cross-sections, profiles and specifications submitted by the City Engineer and filed in the office of the City Clerk on JAN 11 1979 under Document No. 765420, for the improvement of SORRENTO VALLEY ROAD FROM THE NORTHERLY LINE OF PARCEL 5 OF ACRE LOT 8, SORRENTO LANDS AND TOWNSITE TO THE EASTERLY TERMINUS OF THE OLD SORRENTO VALLEY ROAD (WATER MAINS) be, and the same are hereby approved and adopted as the official plans, drawings, typical cross-sections, profiles and specifications for said work and improvement.
