

WHEREAS, The City of San Diego is the owner of a portion of Tract B, Rancho El Cajon; and

WHEREAS, The County of San Diego wishes to acquire an easement for drain and slope purposes affecting said property in connection with reconstruction of flood-damaged Woodside Avenue in Lakeside; and

WHEREAS, a County appraisal report which places a value of \$100 on the rights sought has been reviewed and approved by City Property Department staff; and

WHEREAS, the grant of easement has been approved by the Water Utilities Department; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and City Clerk are hereby authorized to execute a grant deed conveying to the County of San Diego an easement for drain and slope purposes affecting all that portion of Tract, B, Rancho El Cajon.

2. That the City Manager is hereby authorized and empowered to execute a Real Property Contract which provides for the transfer of said easement interest to the County of San Diego.

3. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
