
Adopted on JAN 22 1979 (Revised)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street, water, sewer and drainage easement deeds of THE STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION, executed in favor of The City of San Diego, conveying to said City all that portion of Lot 50 of The Highlands, as more particularly described in said deeds, be and the same are hereby approved; and that the land therein conveyed as street easement Parcel 1 is hereby dedicated as and for a public street and the same is hereby named OPPORTUNITY ROAD; and that the land therein conveyed as street easement Parcel 2 is hereby dedicated as and for a public street and the same is hereby named RUFFNER STREET; and that the land therein conveyed as street easement Parcel 3 is hereby dedicated as and for a public street and the same is hereby named DAGGET STREET.

That the City Clerk is hereby authorized and directed to deliver said deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.
