

RESOLUTION No. 222647 (R. 79-1252)


Adopted on JAN 22 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of a street easement deed of GIOVAN B. TARANTINO and MARGHERITA TARANTINO, executed in favor of The City of San Diego, bearing date of November 29, 1978, conveying to said City a permanent easement and right of way for public street, and incidents thereto, over, under, upon, along and across all that portion of the Northwest Quarter of Lot 5 of Horton's Purchase in the Ex-Mission Lands of San Diego, as more particularly described in said deed, be and the same is hereby approved; and that the land therein conveyed for street purposes is hereby dedicated as and for a public street and the same is hereby named SHAMROCK STREET.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.
