- 3. That the City Auditor and Comptroller is hereby authorized to transfer \$25,000.00 from Capital Outlay Fund 245, Park & Ride Project (CIP 55-011) to Clairemont Mesa Boulevard Master Traffic Signal Control System (CIP 62-006); and \$10,000.00 to the Unallocated Reserve CIP 90-2720 "Bicycle Lane Unallocated Reserve".
- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$4,100.00 from CIP 61-131 "Clairemont Mesa Boulevard Doliva Drive" to CIP 62-006 "Clairemont Mesa Boulevard Master Traffic Signal Control System Phase 1".
- 5. That the bid of \$498,589.30 by SELECT! ELECTRIC INC., a corporation, for CONSTRUCTION OF MASTER TRAFFIC SIGNAL CONTROL SYSTEM ON CLAIREMONT MESA BOULEVARD FROM CLAIREMONT DRIVE TO DOLIVA DRIVE AND ON CLAIREMONT DRIVE FROM CLAIREMONT MESA BOULEVARD TO COLE STREET, San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 763/13.
- 6. That the expenditure of \$167,200.00 from Capital Outlay Reserve, Fund 245, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
