BE IT FURTHER RESOLVED, that the expenditure of \$62,900 as hard cash match for the ARJIS grant (\$29,900 budgeted for FY 1979 and \$33,000 will be budgeted in FY 1980), is hereby authorized, solely and exclusively for the above purpose.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Comprehensive Planning Organization (CPO) by which CPO will assume development responsibilities of the ARJIS grant for the balance of the grant term, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as
