

RESOLUTION NO. 222662Adopted on JAN 23 1979

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John E. Hoaglin	Property	\$ 485	One year ago, Mr. Hoaglin suggested that the fork lift trucks at San Diego Stadium be rebuilt rather than purchasing new trucks. One year's experience has substantiated a savings of \$6,867. This is the remainder of Mr. Hoaglin's award.
Michael N. Malta	General Services	\$ 380	Mr. Malta is a Welder in the Equipment Division. He suggested that the City weld using flux core with CO ₂ shielding rather than ARC welding. The new welding provides continuous wire feeding and reduces welding time. First year's savings are \$3,800.
James A. McQuary	General Services	\$ 225	One year ago, Mr. McQuary suggested that the City purchase pre-cut painted over signs rather than buying new sign plates. One year's experience has shown a savings of \$4,013. This is the remainder of Mr. McQuary's award.
Fred W. Rueger	General Services	\$ 135	Mr. Rueger was an Electrician in the Buildings Division at the time of his suggestion. He suggested that ballasts be disconnected in fluorescent light fixtures where the tubes have been removed. This is expected to save \$2,700 per year in energy costs. This is a partial award pending a final 12-month review.
