NAME	DEPARTMENT	AMOUNT	SUGGESTION
Thomas B. Wells	General Services	\$ 90	Mr. Wells is a Carpenter in the Buildings Division. He suggested that bench seating at the Starlight Bowl be attached directly to the concrete using fabricated brackets rather than use the bolted wood block method. This is expected to save the City \$1,853 annually in repair costs. This is a partial award pending a final 12-month review.
Robert E. Minter	General Services	\$ 80	Robert E. Minter is an Electrician in the Buildings Division. He suggested that switches be added to 14 rooms in the City Operations Building. This is expected to save \$1,630 annually in energy costs. This is a partial award pending a final 12-month review.
Albert M. Mases	General Services	\$ <b>7</b> 5	Mr. Mases is an Equipment Service Supervisor in the Equipment Division. He suggested that a drill motor pump be used to remove cil from the rear engines of sweepers. This is expected to save \$730 annually in the time it takes to change the oil.
Thomas Foster  APPROVED:	General Services  MICH  JOHN W, WITT, City Accorn-	1	Mr. Foster is an Apprentice II in the Communications and Electrical Division. He suggested that fluorescent u-tubes, ballasts, and fuses in one-way signs be replaced with strip lighting fixtures. This saves an estimated \$1,447 annually in energy and maintenance costs. This is a partial award pending 12-month review.
