WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Christine Cyrankowski	General Services	\$ 55	Ms. Cyrankowski was an Intermediate Typist in the Solid Waste Division at the time of her suggestion. She suggested that the Employee Attendance Summary be revised for the Solid Waste Division. This saves \$562 annually in the time it takes to use this form.
Mary F. Labiak	Park and Recreation	\$ 50	One year ago Ms. Labiak suggested that the street tree ordinances be revised to reflect the responsibility of the homeowner. This has proven to be of extreme value to the City. This is the remainder of her award.
Glen A. Paulen	General Services	\$ 50	Approximately one year ago Mr. Paulen suggested that end and center blades for landfill dozers be rebuilt rather than purchased. One year's experience has shown a savings of \$4,932. This is the remainder of his award.
Thomas B. Wells	General Services	\$ 50	Mr. Wells is a Carpenter in the Buildings Division. He suggested window sash weights be replaced by sash balance in a Balboa Park building. This is expected to save \$1,064 in maintenance costs. This is a partial award pending a final 12-month review.
