WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
William C. Buscher	Park and Recreation	\$ 50	Mr. Buscher is a Utility Worker I in the Parks Division. He suggested a more efficient system for the release of trailers during the dumping procedure. This is a significant safety and equipment improvement.
William V. Nery	General Services	\$ 40	Mr. Nery is an Equipment Mechanic in the Equipment Division. He suggested that a quick disconnecting coupling be used to change oil for fixed cab masters. This is expected to save \$825 annually. This is a partial award pending a final 12-month review.
JoAnn Kolodinski	City Auditor	\$ 30	Ms. Kolodinski is an Account Clerk. She suggested a procedure to minimize the handling and recopying of the Auditor's Office Biweekly Work Unit Report. This saves \$300 yearly.
Louis Denov	General Services	\$ 25	One year ago Mr. Denov suggested that a compartment be built into the mobile repair van for equipment storage. One year's experience has shown a savings of \$1,099. This is the remainder of his award.
John J. Tomlin	Park and Recreation	\$ 25	Mr. Tomlin is a Groundskeeper in the Parks Division. He suggested that a control valve be installed on hose bibs in certain facilities in the Mission Bay area. This is expected to save on water costs and prevent damage to grassed areas.
