<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Susie McCarty	Park and Recreation	\$ 20	Ms. McCarty is a Lifeguard I in the Aquatics Division. She suggested that international symbols be added to red flags used to delineate no swimming areas. This is felt to be a significant safety improvement.
Delorese J. Shafer	Risk Management	\$ 20	Ms. Shafer is an Intermediate Typist. She suggested that Management Compensation Plan Life Insurance applications be color coded. Estimated savings are \$200 annually.
Phillip J. Love	General Services	\$ 15	Mr. Love is a Carpenter Supervisor in the Buildings Division. He suggested that the City purchase and use a certain grade of plywood. Estimated annual savings are \$171.
Billy J. Hereford	Park and Recreation	\$ 15	Mr. Hereford is a Custodian II in the Community Services Division. He suggested that "No Street Shoes Allowed" signs be posted in all recreation center gyms. This was felt to be a significant maintenance improvement.
