2. That the City Auditor and Comptroller is hereby authorized to rescind Resolution No. 218900 adopted on July 26, 1977 and return the \$165,000.00 to C.I.P. 29-160 for this purpose and related costs.
3. That the expenditure of \$9,700.00 is hereby authorized out of Park Services District No. 15615 for this purpose and related costs.
