
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to pay the sum of \$8,250.00 to each of the five plaintiffs in Barbee, et al. v. City of San Diego, et al. (United States District Court for the Southern District of California Case No. 76-0051-E), for a total of \$41,250.00, as full settlement of said lawsuit and any and all of plaintiffs' claims against The City of San Diego, its agents and employees, resulting from the plaintiffs' previous employment as firefighters in the San Diego Fire Department.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue five warrant-checks in the amount of \$8,250.00 each, said warrant-checks to be made payable as follows: one check payable to "Pattie Barbee and her attorney, Sheridan Reed," one check payable to "Kathleen Carey and her attorney, Sheridan Reed," one check payable to "Michele McDougal and her attorney, Sheridan Reed," one check payable to "Madelyn Tillory and her attorney, Sheridan Reed," and one check payable to "Carol Tyler and her attorney, Sheridan Reed." These warrant-checks shall constitute full settlement of the lawsuit and claims mentioned above.
