BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That all bids heretofore received on April 6, 1978 pursuant to publication of notice calling for bids for the CONSTRUCTION OF THE PACIFIC BEACH PARK NORTH COMFORT STATION are hereby rejected.
2. That the City Auditor and Comptroller is hereby authorized to delete the Pacific Beach Park North Comfort Station, C.I.P. No. 23-162 from the Capital Improvements Program.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$43,000.00 from the Park and Recreation Bond Fund, 725, C.I.P. No. 23-162 to C.I.P. 23-606 Beach Comfort Station.
4. That the City Auditor and Comptroller is hereby authorized to transfer \$47,000.00 from the Capital Outlay Fund 245 C.I.P. No. 23-162 to the Capital Outlay Fund Reserve.
