

RESOLUTION NO. 222695 (R.79-1337)

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street to be vacated has been superseded by relocation; and

WHEREAS, a portion of PARADISE VALLEY ROAD (ROAD SURVEY 609) has been relocated by the streets dedicated with the acceptance of the final map of the subdivision to be known as PARADISE GARDENS WEST UNIT NO. 1; and


WHEREAS, those properties adjoining the portion of PARADISE VALLEY ROAD to be vacated will continue to have access or will be accessible by the streets which will be dedicated on the subdivision map; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of PARADISE VALLEY ROAD (ROAD SURVEY 609), as more particularly shown on Drawing No. 14433-B on file in the office of the City Clerk as Document No. 765595, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
