

RESOLUTION No. 222702 (R-79-1088)

Adopted on JAN 29 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to modify the Housing and Conservation Program (17.60) as authorized in the Fiscal Year 1979 Building Inspection Department budget to:

1. Reinstitute, on a limited basis, investigation and enforcement action in cases of reported substandard housing conditions in occupied 1- and 2-unit residential buildings (Nonregulated Housing, 17.65).
2. Reinstitute, on a limited basis, investigation and abatement action in cases of abandoned and/or damaged buildings (17.63).
3. Discontinue periodic inspection of apartment and hotel buildings as a means of controlling substandard housing conditions and replace with a program of complaint/referral investigation, and to reassign budgeted staff as necessary, in order to identify and remedy those instances of substandard housing conditions and unsafe buildings which have the greatest impact on public safety.
