WHEREAS, it is to the mutual benefit of CITY and LA JOLLA YOUTH, INC. (LJY), to contribute jointly to the establishment of recreational facilities which can serve the needs of both the La Jolla Community and the general public; and

WHEREAS, CITY and LJY have been cooperating in the use of other recreational facilities at Cliffridge Park in La Jolla; and

WHEREAS, CITY owns in fee simple that parcel of land known as the Theatre Arts Site; and

WHEREAS, CITY does not currently have funds budgeted to develop said site; and

WHEREAS, LJY desires to construct and develop certain recreational improvements on said site in conjunction with local community groups; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Lease Agreement with LA JOLLA YOUTH, INC., whereby City leases approximately 6.5 acres of City-owned land in La Jolla, for a period of twenty-five years, under the terms and conditions set forth in the lease agreement on file in the office of the City Clerk as Document No. 765592.
