
BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "BARCLAY SQUARE Being a subdivision of a portion of Lots 12 and 21, and all of Lots 13 through 18 inclusive, and Lots 22, 23 and 24 of Triumph Annex, Unit No. 2, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5093, filed in the office of County Recorder of San Diego County December 17, 1962, together with Beadnell Way, Cannington Drive, the east half of the Alley adjoining Lot 24 on the west, and all of the Alley adjoining Lots 21, 22, 23 and 24 as dedicated on Map No. 5093.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
