APPROVING MAP OF MIRA MESA VERDE UNIT NO. 28
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE
MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by
WILLIAM GREGORY CLARKE, a Licensed Surveyor, entitled "MIRA MESA
VERDE UNIT NO. 28 Being a subdivision of Lot 3309 of Mira
Mesa Verde No. 27 according to Map thereof No. 7038 filed in
the office of the County Recorder of San Diego County, September 8,
1971, in the City of San Diego, County of San Diego, State of
California.", is made in the manner and form prescribed by law
and conforms to the surrounding surveys; that said map and the
subdivision of land shown thereon is hereby approved and accepted;
and said Council hereby accepts on behalf of the public, the
following: Tupelo Cove and Acama Place for public purposes, and
said streets are hereby declared to be public streets and dedicated
to the public use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
said public streets are accepted on behalf of the public as
heretofore stated.


BE IT FURTHER RESOLVED, that said Council hereby acknowledges
