WHEREAS, the Engineering and Development Department has requested that the City quitclaim to LION PROPERTY CORPORATION, a California corporation, its interest in and to said easement; and

WHEREAS, the owner of the property wishes to clear title to its property; and

WHEREAS, the herein described property is surplus to City needs; and

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. 765625, quitclaiming to LION PROPERTY CORPORATION, a California corporation, that certain easement, as more particularly described in said quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
