WHEREAS, The City of San Diego is the owner of a sewer easement affecting Pueblo Lots 1173 and 1182 of the Pueblo Lands of San Diego; and

WHEREAS, the Property Department has requested that the City quitclaim to H. G. FENTON MATERIAL COMPANY, a California corporation, its interest in and to said easement; and

WHEREAS, the owner of the property wishes to clear title to its property; and

WHEREAS, the herein described property is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City quidelines for implementation of said Act, as amended; and

WHEREAS, The City desires to negotiate the sale of said easement to H. G. FENTON MATERIAL COMPANY, a California corporation, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property, as determined by Staff, is the sum of Nine Thousand Four Hundred Thirty-Five Dollars (\$9,435), but on February 23, 1973, the City acquired a sewer easement from H. G. FENTON MATERIAL COMPANY, a California corporation, to replace the easement proposed to be conveyed and the easement received was valued at \$9,610 so that no additional payment should be received for this conveyence;

G. FENTON MATERIAL COMPANY, a California corporation.
- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. 765626, quitclaiming to H. G. FENTON MATERIAL COMPANY, a California corporation, that certain easement, as more particularly described in said quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
