BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Exhibit B of the La Jolla Shores Planned District Conflict of Interest Code be, and it is hereby amended to read as follows:

"EXHIBIT B

Category 1: Report all interest in investments, interests in real property or income if the business entity in which the investment is held, the interest in real property, or the income or source of income may foreseeably be affected materially by any decision made or participated in by the Chairperson or board member.

If reportable income is derived from a business entity providing legal or brokerage services, the provisions of Section 303 C.2. of this Conflict of Interest Code shall apply to each client whose payment for legal or brokerage services constitutes reportable income as defined above.

If reportable income is derived from a business entity other than one providing legal or brokerage services, the provisions of Section 303 C.3. of the Conflict of Interest Code shall apply to each customer whose payments constitute reportable income as defined above."
