BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be, and he is hereby authorized to transfer \$29,775 from Non Personnel Services (\$27,200 from Library Department 20.32/3360 and \$2,575 from Library Department 20.20/3360) to Personnel Services (\$29,432 to Library Department 20.32/1151; \$54 to Library Department 20.32/2424 and \$289 to Library Department 20.32/2426), solely and exclusively for the purpose of providing funds for hourly staff to insure all branches are open a minimum of forty (40) hours per week, and to insure that eight branches are open for forty eight (48) hours per week.
