WHEREAS, on December 12, 1978, the Old San Diego Planned District Review Board denied said application and filed said decision in the office of the City Clerk on January 8, 1979; and

WHEREAS, on December 28, 1978, pursuant to the provisions of Section 103.0203.3 of the San Diego Municipal Code, PAUL WOLFF appealed the decision of the Old San Diego Planned District Review Board; and

WHEREAS, said appeal was set for public hearing on February 6, 1979, and testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; and

WHEREAS, the City Council in considering said appeal is empowered by the provisions of Municipal Code Section 103.0202.3, to affirm, reverse or modify, in whole or in part, any determination of the Old San Diego Planned District Review Board, subject to the limitations as are placed upon the Old San Diego Planned District Review Board by the Municipal Code; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego,
