SPLITSTONE, a Registered Civil Engineer, entitled "LAKEWOOD VILLA UNIT NO. 2 Being a subdivision of Lots 32, 306, 339, 340, 373, 374 and 407 of San Carlos Unit No. 4, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 4298, filed in the office of County Recorder of San Diego County on August 11, 1959, together with portions of Lake Ben Avenue, Lake Gaby Avenue, Bashan Lake Avenue, Navajo Road and Bisby Lake Avenue adjoining said lots as dedicated on said Map No. 4298.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
