A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF BROADWAY ADJACENT TO BLOCK 125, MAP 167, AND 32ND STREET BETWEEN BROADWAY AND STATE HIGHWAY 94 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the streets hereinafter mentioned; and in connection therewith require the reservation of certain easements for portions of Broadway and 32nd street in the area covered by such streets.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of portions of Broadway and 32nd Street, as more particularly shown on Drawing No. 14504-B on file in the office of the City Clerk as Document No. **765660**

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 P.M. MAR 20 1979 the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper
