

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, portions of "A" Street, Ash Street, Beech Street, Cedar Street, Date Street, 36th Street, McClellan Street, Choate Street, and 37th Street have been relocated by the approval on this date of the dedication of the street system within the subdivision to be known as American Pie; and

WHEREAS, those properties adjoining those portions of "A" Street, Ash Street, Beech Street, Cedar Street, Date Street, 36th Street, McClellan Street, Choate Street, and 37th Street to be vacated, will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as American Pie; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That portions of "A" Street, Ash Street, Beech Street, Cedar Street, Date Street, 36th Street, McClellan Street, Choate Street, and 37th Street, as more particularly shown on Drawing No. 14425-B, on file in the office of the City Clerk as Document No. 765732, which is by this reference incorporated herein and made a part thereof, be and the same are hereby ordered vacated.

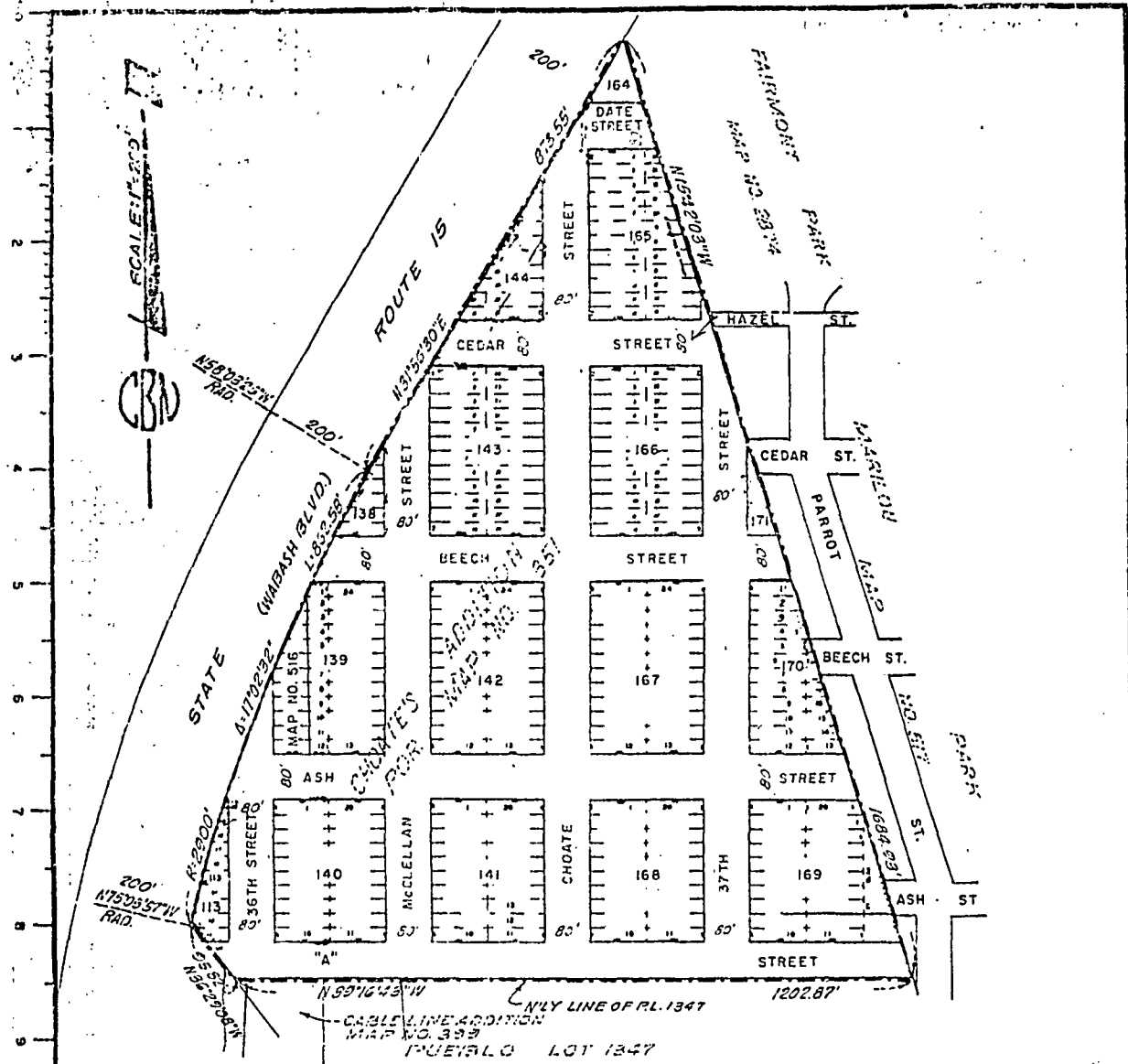
