That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| Tom F. Weiks | General Services | \$ 90 | Mr. Weiks was a Senior Utility Supervisor in the Streets Division. He suggested that damaged aluminum sign posts be salvaged to make new sign posts. First year's savings are expected to be \$1,890. This is a partial award pending a final 12-month review. |
| Robert J. Hlavka | General Services | \$ 60 | Mr. Hlavka is a Welder in the Streets Division. He revised the design for pole mounted trash cans to remove the stress caused by improper weight distribution. Savings are estimated at \$604 annually. |
| Robert C. Nightingale | Planning | \$ 55 | Mr. Nightingale is a Zoning Representative. He suggested that swimming pool applications no longer be submitted to Zoning for approval. Since this is already done elsewhere, estimated savings are \$1,060. This is a partial award pending a final 12-month review. |
| Edna Gonzales | Police | \$ 50 | Ms. Gonzales is an Intermediate Typist. She suggested that one copy of the jail booking log be eliminated from the Police Department's delivery schedule. This is expected to save \$1,026 annually. This is a partial award pending a final 12-month review. |
